How do you submit data to your pension scheme?

As an employer you must regularly submit data to your pension scheme. Using paper forms causes a significant overhead in terms of administration effort. Employers who submit data electronically often capture the information manually by typing it into a spreadsheet, increasing operational risk.

Existing processes rely on your payroll team identifying changes and submitting the appropriate data to the fund. How can you be sure your submissions are accurate?

CARE regulations impose new employers duties to provide monthly information for each scheme member:

- total pay in the main and 50:50 sections
- total employee contributions
- total employer contributions
- · total additional contributions

This further increases workloads for both the employer and the pension department. i-Connect helps employers meet their obligations for the regular transmission of data to the pension scheme.

An employer who submits Annual Allowance data two months late is liable for a fine of up to £3,900.

The Pensions Regulator code of practice, effective from 1 April 2015, requires robust systems and procedures to be in place for the supply and reconciliation of data, encompassing:

- Monitoring the quality of data for accuracy and completeness
- Reviewing and assessing the quality of data with regular evaluations
- Regular Reconciliation of member data between employer and pension systems, to ensure that starters and leavers are identified and accurate addresses are held
- Meticulous recording of data by ensuring employers are providing timely and accurate data to the pension scheme

The Regulator will be focused on maximising employer compliance with employer duties.
